The Opioid Treatment Center (OTC) is built around someone dealing with the daily struggles of Opioid Use Disorder, help is here. Each referral will be reviewed for program eligibility and need of services. Our goal is to provide a comprehensive array of recovery treatment, and psycho-social rehabilitation services to assist individuals in utilizing professional, community, and natural supports to address their needs. We cannot achieve these goals alone, our community is in need and together we can change.

WHO IS ELIGIBLE TO THE PROGRAM?

- Must be 18 years of age
- May not be currently incarcerated

PLEASE NOTE: Treatment services will only be offered for participants at Dodge County Human Services and Health Department and FDL County Department of Community Programs office locations.

DODGE COUNTY SERVICES:

FOND DU LAC COUNTY SERVICES:

1. Once OTC Staff receives the referral, we will make contact within 48 hours, or immediately if the client has urgent needs, and then up to two weeks, from the initial referral date. Upon contact, schedule their intake. Additional assessments and OTC staff will issue support at this time, as well.
2. The clients will be assigned to a (RSS) Recovery Support Specialist- Case Manager and meet within 7 days, together they'll create an (IRP) Individual Recovery Plan. This will include identifying a network of support and address other life barriers.
3. In 14 days, the case is reviewed to determine additional needs of the client, continuing to report once per week.
4. Every 30 days, the client, identified support system, counselor, RSS, anyone else that the client would like to be a part of identifying the IRP will meet to review their IRP. At each meeting, it is noted the client is the focus and in charge of identifying their specific needs, empowering them to want to make change.
5. This is a voluntary program, clients will have the option to stay in the program for as long as there is a need for them. Some clients may range depending on their needs. Additional referrals to other community programs will be established prior to discharge.
6. Referrals are accepted from all sources, determination of program eligibility will be made by OTC staff.
